# **ALRP Welcomes Bill Hirsh, New Executive Director**

Bill has over ten years of community based nonprofit experience with organizations, most recently serving as Executive Director of the Mental Health Association of San Francisco. He has also been a welfare rights attorney and directing attorney for the Mental Health Advocacy Project of the Santa Clara County Bar Association.

Bill first encountered the AIDS Legal Referral Panel in 1986 as a new Golden Gate University Law School graduate. "During the early years of the AIDS epidemic, ALRP operated out of a cubicle in an agency where I was interning. There was an urgency to ALRP's work. The Wills on Wheels program brought attorneys to the bedsides of persons unlikely to survive their hospital stay." Bill continued, " I was trained by ALRP to draft wills; now I have the opportunity to lead an organization assisting clients in the full range of civil legal issues people living with HIV confront. Housing, healthcare insurance, employment and family law matters have moved to the forefront of the legal arena for ALRP clients,

and ALRP's legal services have expanded to meet the needs of our clients. The epidemic is not over; the need to protect the legal rights of people affected by HIV/AIDS has not ended."

Bill is a thoughtful, very upbeat individual who has a unique charm all his own. Preferring Birkenstock sandals, Bill is a casual, down-to-earth guy. He and his "handsome" (Bill said to say this) partner live in Bernal Heights, where Bill pursues a newly found interest in gardening. Things are really changing in the ALRP Housing Advocacy Project. The Project now has two full-time staff attorneys, Aleem Raja and Joyce Jordan, who represent clients in litigation of housing matters. The Project's focus has primarily been on eviction defense, but we are eagerly gearing up for filing our first affirmative action. In that case, the ALRP is ready to file suit against a landlord who has refused to recognize a couple's domestic partnership and is proceeding with an eviction based on allega-

tions that the partner is an unauthorized sub-tenant.

Each week, we get calls from at least a half dozen new callers who are facing eviction. In recent weeks we have seen a rash of Ellis Act evictions, for which there is arguably no substantive defense. These evictions are in response to an anticipated change in the current law that allows owners to "Ellis" a multi-unit building off the rental market and then sell the building as a tenancy-in-common. Individual buyers form groups of "tenants in common" who will each live in a unit in the building.

This practice may abruptly come to an end in November when a ballot measure is put before San Francisco

voters that would force the owners of an "Ellised" building to comply with the City's current condo-conversion requirements such as a lottery selection process.

Under most circumstances, an owner is required to serve a 120 day notice to quit under the Ellis Act. Landlords have been rushing to serve these notices so they can empty their buildings and benefit from the soaring prices of San Francisco real estate before the rent ordinance is possibly changed as a result of the November election. Recently, a tenant showed me a realtor's advertisement listing the sale prices of all the flats in his building. Bids starting at \$385,000 are currently being taken for this tenant's two bedroom flat in the Western Addition! In an interesting twist, because this client is disabled, the Ellis Act provides an extension of the notice period for one year - well past the November election. Most likely, the landlord will be offering a hefty figure for this gentleman's moving expenses in the near future.

Other cases that the Housing Project sees quite often are cases where a client with mental disabilities has recieved an eviction notice based on nuisance. Often this behavior is a direct result of the client's mental disability and could have been prevented with proper mental health care. A recent case involved allegations of a client going into the wrong apartment and into the bed of an elderly neighbor ecause he wasintoxicated. After months of litigation and negotiating, the landlord reluctantly agreed to reasonably accommodate this client's disability. It was shown that the client was not taking his prescriptions for his mental health problems but was selfmedicating himself with alcohol instead. The parties agreed to the accommodation of allowing the client to

> begin a mental health program including the medications he had previously been on and regular psychological therapy sessions.

As you can see, landlord-tenant issues are a very interesting and volatile area of law in San Francisco at this time. Each day the Housing Project gets calls from new clients facing homelessness. In March, a list of current evictions and affirmative actions available for referral was e-mailed to the panel attorneys listed with the ALRP as landord-tenant attorneys. As a result, all but the "man in the bed" case described above were referred out with successful results for each client. A new e-mail with housing cases available to

panel attorneys will soon go out. If you are interested in receiving this list, forward your e-mail address to joyce@alrp.org.

#### ALRP CONTINUES TO FIGHT FOR THE RIGHTS OF PREGNANT WOMEN AND CHIL-DREN - AND THUS FOR US ALL

#### California Legislation

In February of 2000, AB 2809 (Robert Pacheco-R, Walnut) was introduced in the California Legislature that would have made testing of pregnant women "routine" during prenatal care and during labor and delivery. *No counseling* would have been provided

and women would have merely had the right of refusal, with *no informed consent* (unlike most other classes of individuals in California). While California currently does not report cases of HIV, this bill would have also authorized the *reporting of names* of pregnant women to the State Department of Health Services. The bill — sponsored by the California Medical Association

(CMA) — would have repealed current law, which mandates prenatal care providers to *offer* HIV information, counseling and testing. This, in spite of the fact that from the date at which current law was implemented (1996) through 1999, perinatal AIDS cases diagnosed in California have dropped by 78%, and according to the State Office of AIDS, the total number of cases of perinatally acquired AIDS diagnosed in California in 1999 was seven (7).

Upon introduction of AB 2809, ALRP's Public Policy Director immediately began organizing throughout the state to educate the HIV community, legislators and other policy makers as to the critical problems of the bill. From forming a coalition effort to working with the statewide California HIV Advocacy Coalition (CHAC), to training women with HIV to speak to the Legislature, ALRP was instrumental in creating strong and vocal opposition to this attempt to give pregnant women with HIV fewer rights than others with HIV and to open the door — for us all — to HIV name reporting and a reduced focus on the importance of HIV counseling, along with our right to written, informed consent. When the bill was heard in its first committee - the Assembly Committee on Health - proponents and opponents were requested to negotiate a compromise. Subsequently, a meeting was held and, with the assistance of Members of the Committee and their staff, a compromise was hammered out and later proposed to the Assembly Health Committee. The Committee unanimously passed the amended version and the bill is now moving through the legislative process.

In its amended form, the bill retains current

law and *modifies* it by specifically offering HIV testing and counseling not only during prenatal care, but again during labor and delivery. Because the sponsor of the bill, the CMA, believes that providers are not following current law, the bill also authorizes a form to be developed that would be used for the patient to note that she had, in fact, been offered counseling and testing. In addition, the form would be used for the woman to give her written consent, should she desire, after being counseled, to be tested for HIV. *ALRP has removed our opposition to the bill.* 

#### Federal Legislation

At the federal level, in May, Representative Ackerman-D, of New York, and Representative Coburn-R, of Oklahoma, introduced HR 4426, the "Women and Children's HIV Protection Act of 2000." In an ominous reminder of the struggle with the Reauthorization of the Ryan White CARE Act in 1996, this bill

would again keep Title II funding out of states that do not mandate the testing of newborns whose mothers were not previously tested during prenatal care. The strategy used in 2000 by Representatives Coburn and Ackerman has been to keep this agenda out of the CARE Act, to work with HIV policy advocates to create a "reasonable" CARE Act that advocates might be able to support and then to drop this bill during the CARE Act process. It remains to be see whether HIV policy advocates will fight this bill as powerfully as they are currently fighting for a solid CARE Act. ALRP is organizing nationally to defeat this bill and to keep it from being attached to the CARE Act Reauthorization. To date, only a handful of women and HIV advocates have yet joined us in tackling this bill.

#### **CARE Act Update**

Meanwhile, the Care Act (S. 2311) has gained broad bipartisan support in Congress and was unanimously approved by the Senate Health, Education, Labor and Pensions (HELP) Committee in April. While the number of Senate co-sponsors of the CARE Act continues to grow, Senators Feinstein and Boxer have still not signed on as of the date this newsletter goes to print.

#### California Budget Update

Governor Davis recently released his revised State Budget, based on a projected \$12.3 billion surplus. However, the Governor did not include any new funding for HIV programs. The California HIV Ad-

vocacy Coalition (CHAC), of which ALRP is an active member, advocated strongly for an increase in the budget of \$14.8 million and was successful in moving both the Senate and Assembly Budget Committees to approve expanded HIV funding. CHAC advocated for \$8 million to expand services for communities of color; \$2.8 to develop and implement a non-name based HIV reporting system; \$3 million for HIV drug resistance testOrleans in the time from Anita Bryant to AIDS, <u>Some of Them Sparkle</u> will tell stories of the wonderful and colorful people of that city. 


